The Clean Vehicle Rebate Project (CVRP) promotes clean vehicle adoption in California by offering rebates of up to \$7,000 for the purchase or lease of new, eligible zero-emission vehicles, including electric, plug-in hybrid electric and fuel cell vehicles.	
The Center for Sustainable Energy (CSE) administers CVRP throughout the state for the California Air Resources Board (CARB). The CARB is a part of the California Environmental Protection Agency (CalEPA) and exists to promote and protect public health, welfare and ecological resources through the effective and efficient reduction of air pollutants while recognizing and considering the effects on the economy of the state. CVRP funding is determined by an annual funding plan that is developed with public input and approved by the CARB.



More Californians now have access to EVs as CVRP offers a standard rebate and an increased rebate for income qualifying households. This provides an amazing opportunity to offer even more savings to your EV customers.


Use following is messaging in promotions of your EV models. Visit the **Eligible Vehicle** page to see what level your models qualify for.

- Battery EV (BEV) Receive \$2,000-\$7,500 through CVRP when you purchase a [MODEL NAME].
- Fuel Cell EV (FCEV) Receive \$4,500-\$7,500 through CVRP when you purchase a [MODEL NAME].
- Plugln Hybrid EV (PHEV) Receive \$1,000-\$6,500 through CVRP when you purchase a [MODEL NAME].


Website

Featuring the CVRP incentive on your website will inform customers of the savings available and showcase your website as an EV resource to customers. Here are a few ways to integrate CVRP on your website.
